REGULAR MONTHLY MEETING OF THE VILLAGE OF VIRGINIA GARDENS, FLORIDA THURSDAY, OCTOBER 18, 2018 TOWN HALL 6:30 P.M.

CALL TO ORDER: The meeting was called to order by Council President Arce at 6:32 p.m.

INVOCATION (MOMENT OF SILENCE)

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Chaplain DaSilva.

1. APPROVAL OF MINUTES

A. Regular Council Meeting – September 20, 2018 A motion by Council Member Block to approve the minutes of the Regular Council Meeting of September 20, 2018 was seconded by Council Member Taylor Martinez. The motion passed 5-0.

B. Final Budget Hearing Meeting – September 24, 2018

A motion by Council Member Taylor Martinez to approve the minutes of the Final Budget Hearing Meeting of September 24, 2018 was seconded by Council Member Conover. The motion passed 5-0.

2. **BEAUTIFICATION**

A. Council President Arce reported that the minutes for October 4, 2018 have been submitted.

Mr. Martinez reported that Israel Landscaping is going through the Village trimming trees. Mr. Martinez reported that Mr. Carrasco is requesting the Village to remove the Black Olive tree on the swale in front of his property. Mr. Martinez reported that this is an ongoing situation with Mr. Carrasco. Mayor Deno reported that there is nothing wrong with the tree so we cannot have it removed and suggested that Israel

Landscaping take a look at the tree to check if it needs to be trimmed and that there are no branches on the property.

Mr. Martinez thanked Police Chief Hernandez for the two new Yard of the month signs.

3. MAYOR'S REPORT

A. Request approval for \$30.00 Holiday Gift Cards to be provided for all Village Employees for the Thanksgiving and Christmas Holidays

Mayor Deno is requesting Council approval for \$30.00 Holiday Gift cards. A motion by Council Member Conover to approve the \$30.00 gift Cards was seconded by Council Member Taylor Martinez. The motion passed 5-0.

B. Request council approval for the results of the evaluation committee for the RFQ-DR2018 (Debris removal contractors)

Mayor Deno reported that the Village of Virginia Gardens contract with debris removal company expired. Following the FEMA and federal guidelines, we put out a public bid for debris contractors a few months ago. The Village received 4 responses. An evaluation review committee made up of Public Works Director James Martin, Village Architect Manuel Perez and Planning & Zoning Chairman Virginia Howard was created to rank the 4 respondents according to the following criteria:

- 1) Qualifications of the Respondent
- 2) Proposed Approach, understanding of and Response to Scope
- 3) Similar Projects completed by Proposed Project Manager and other Key Personnel
- 4) References

Mayor Deno reported that a public meeting was held to tabulate and rank the committee scores on September 20, 2018. Each of their individual scores were tabulated to obtain a grand total score for each respondent. The highest grant total possible being 300 points. The three highest ranking respondents will comprise the pool of qualified firms that we will request prices and contracts from.

Mayor Deno reported that the Final Rating is as follows:

- 1) DRC EMERGENCY SERVICES 270 points
- 2) TFR ENTERPRISES 257 points
- 3) WORLD WASTE RECYCLING 235 points

A motion by Council Member Conover to approve the results and move forward and request prices and contracts from the final ratings respondents was seconded by Council Member Taylor Martinez. The motion passed 5-0.

Mayor Deno stated that he received complements regarding the new BBQ area and the Tike Hut should be installed in the next few days. Council Member Taylor Martinez suggested that we should dedicate the BBQ area in Ray Saldarriaga's memory.
