1. APPROVAL OF MINUTES

Attorney Cuadra stated that our off-duty details are now currently running correctly and compliantly.

Attorney Cuadra reported that we will have an off-duty program ready by the next meeting.

11. ATTORNEY'S REPORT

A. RESOLUTION NO. 955

A RESOLUTION OF THE VILLAGE OF VIRGINIA GARDENS, FLORIDA, URGING THE FLORIDA LEGISLATURE TO TAKE IMMEDIATE ACTION IN ADDRESSING THE HEALTH CRISIS PRESENTED BY THE USE OF E-CIGARETTES BY BANNKIN AND/OR RESTRICTING SALES TO MINORS.

Attorney Cuadra is requesting Council Approval of Resolution No. 955 and urges the Florida Legislature to take immediate and direct action in addressing the grave health crisis relation to e-cigarette use by minors by banning and or restricting e-cigarettes sales to minor.

A motion by Council Member Taylor Martinez to approve Resolution No. 955 was seconded by Council Member Arce. The motion passed 5-0.

B. ORDINANCE NO. 363 – FIRST READING AN ORDINANCE OF THE VILLAGE OF VIRGINIA GARDENS, FLORIDA, AMENDING ORDINANCE NO. 362 RELATING TO PROCEDURES FOR PROCUREMENT AND PURCHASING OF GOODS AND SERVICES; CLARIFYING EXEMPTION PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

Attorney Cuadra stated that Ordinance No 363 amends Ordinance No 362 which should list exemptions to the competitive bidding requirements, omitted list exempt provisions from competitive services. Attorney Cuadra stated that Ordinance No 363 lists the exempt provisions thus correcting a scrivener's error.
